It is clear and notorious that all the problems that Brazil is facing today are **Cultural** and the **Solution** to them does not pass through the hands of the Legislative, Executive and Judiciary powers, nor even through the Public Ministry, since these bodies are demonstrating that they are totally powerless to face a problem that is **Epidemic and Systemic**.

Part of this entire contingent should be acting in the defense of citizens' rights while the other part should be acting in the supervision of the activities of the Executive Branch, thus avoiding everything that is happening in Brazil today as if supervisions did not exist.

The Elo Social, in a constitutionally correct way, created a structure completely uncoupled from the state that aims to make up for its deficiency or inoperability.
